Do not use on greens.

0.7 lb. of Nitrogen = 14 lbs per 1000 sq. ft.
0.9 lb. of Nitrogen = 18 lbs per 1000 sq. ft.

DIRECTIONS FOR USE:

Do not use on greens. Do not apply with a drop-type spreader. Do not apply at rates lower than recommended to prevent mottling. Do not collect clippings for at least one mowing following application to prevent particle pick-up. Do not apply to frozen turf. Turf King is formulated for professional use on turf, including golf courses, sports fields, and landscapes. Specific application rates and frequencies are determined by the professional applicator based on local soils, regulations, and climate.

Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product to your lawn (or garden), and sweep any product that lands on the driveway, sidewalk or street back on to your lawn (or garden). The product may only be applied to the intended application site. Application of non-aquatic fertilizer is prohibited within 15 feet of the top of the bank of a lake, pond, wetland or flowing body of water; unless using targeted application equipment when establishing a stream buffer zone.
