# Applications:

Do not use on greens. Do not apply with a droptype spreader. Do not apply at rates lower than recommended to prevent mottling. Do not collect clippings for at least one mowing following application to prevent particle pick-up. Do not apply to frozen turf. Turf King is formulated for professional use on turf, including golf courses, sports fields, and landscapes. Specific application rates and frequencies are determined by the professional applicator based on local soils, regulations, and climate.

### Storage & Use:

Store in a clean, dry place. Reseal opened bag by folding top down and securing. Use only in clean, dry spreaders. Do not leave unused product in spreaders.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, sweep any product that lands on your driveway, sidewalk, or street back into your lawn.

Iron may stain concrete surfaces and should not be applied on dry or water dampened concrete and should be removed from these areas promptly after applications by sweeping or blowing. Do not wash off with water.
